



## **Membership Application Instructions**

To apply for membership at Fort Bragg Federal Credit Union, simply complete the membership application, sign and mail it along with a photocopy of your military ID; otherwise a copy of your valid driver's license or passport and social security card to the credit union at:

In order to make sure your application is complete and ready to process when we receive it, please review the following tips that correspond to the section on the membership application:

- I. **Accounts & Services** – Please check the box next to the services you are interested in applying for. The Savings box has already been checked for you in order to establish your membership with the credit union.
- II. **Primary Member Information** – Please complete all information and make **sure you check and fully complete one of the reason boxes** that qualifies you for membership.
- III. **Joint Owner/Co-applicant Information** – Please complete all information if there is going to be a joint applicant on the account. ***(Note: joint applicants will have equal access to all funds on deposit under the membership account (e.g. – savings, share draft, and Certificate of Deposit).***
- IV. **Ownership of Account** – Please check at least one of the boxes. ***(Note: If Payable on Death Account is elected, your services will be limited to a share savings account, Certificates of deposit, and loans only)***
- V. **Certifications** – Please check either box A or box B, and follow all the instructions under the section which applies to you.
- VI. **Review The Terms Of The Application** – Please read this important information.
- VII. **Line of Credit** – You may apply for a specific Line of Credit up to \$10,000 or for any amount you may qualify for by checking the box. If your Line of Credit request is approved, you will be notified in writing via mail of the amount and interest rate you qualified for, which is based upon your credit worthiness. If you selected checking as a service in the Account & Services Section, your Line of Credit will be linked to your checking for overdraft protection and you will be issued a Debit Card. You will receive all your documentation and disclosure(s) via mail.
- VIII. **Signatures** – After all steps are completed, please sign (black ink) and have any joint owners sign. Do not forget to include a photocopy of yours and/or any joint applicant's Military ID or valid driver's license/Passport and social security card and a check or money order for \$5.00 with the completed membership application form.

**You must deposit and maintain \$5.00 in your Savings Account to remain a member in good standing.**

### **IMPORTANT INFORMATION ABOUT PROCEDURES FOR OPENING A NEW ACCOUNT**

Proof of Identification will be required by the Credit Union. To help the government fight the funding of terrorism and money laundering activities, Federal law requires all financial institutions to obtain, verify and record information that identifies each person who opens an account. What this means to you: When you open an account, we will ask for your name, address, date of birth and other information that will allow us to identify you. We may also ask to see your driver's license or other identifying documents.
